1	192176	3.1YE	RS	2010	16.525,00	BALKAN INITIATIVE FOR TOLERANCE	May we have your attention, please!	<p>Youth Exchange 3.1 "May we have your attention, please!" will bring together young people from Bosnia and Herzegovina, France, Former Yugoslav Republic of Macedonia, Serbia, Slovenia and Italy in Belgrade to promote anti discrimination through art and culture. Main objective of this exchange is to create public event that will illustrate challenges and everyday life of young people with Autism using creative expression such as photography/dance/video/public communication. Participants will visit the relevant institutions and NGO's dealing with autistic youth that will help us to broaden our understanding and become" more aware of Autism. This insight will guide our artistic workshops and the outcome will be representation of world of people with autism. The idea is to familiarize common people with autism and to break taboo that follows this disorder.</p> <p>24 youngsters, interested in choreography-dance, photography-video, creative writing and event management-production will meet for the first time and share their talents in these fields with main goal to develop intercultural-multimedia happening that will promote inclusion and better understanding of people with Autism.</p> <p>Even with the increase of awareness about Autism in some countries, there is still poor understanding of this disorder in public sphere in all countries participating in this project. We would like to exchange our national practices and experiences through non-formal way, and to advocate for inclusion using more creative way.</p> <p>With belief that image tells more than thousand words, our actions will speak instead of many voices of autistic people that we often pretend not to hear.</p> <p>During these 9 days we will be exploring autism and stereotypes/prejudices that surround people with this disorder. Each participant will use It's own cultural background to give additional value to performing actions that will represent our joint creative expression on Autism. Our results and exploration on this issue will be presented on the last day in front of the public.</p> <p>Each participant will choose one of the four workshops: dance/movement; PR/event management; art/photography/video and creative writing-reflection on Autism (for booklet). During the exchange participants will create program for the public event that will include - performance, video and photography and booklet on Autism. PR group will be in charge of media and public promotion of the event. On the last day presentation will be made for public.</p> <p>We believe that people with autism are often discriminated because of attack of information on this disorder and because it is difficult to understand the world within them. That is why wish to explore around them and to present their world in more creative way.</p>
2	191943	3.1TN	RS	2010	17.166,00	ASSOCIATION PEOPLE S PARLIAMENT	Active participation of unemployed young people facing economic obstacles	<p>Project "Active participation of unemployed young people facing economic obstacles" will gather 2 participants facing social exclusion and discrimination originating in their families low-income status. The project targets young people who are long-term unemployed, those whose families receive social welfare and those who live in some form of poverty. In all, young people with fewer opportunities, usually not aware about these sorts of projects ever happening, and especially those who never had a chance to participate in any type of non-formal education event.</p> <p>These young people will on this occasion have a unique opportunity to participate in an 8-day international training that will be organized for them in City of Nis, Republic of Serbia. Unemployed young people facing serious economic obstacles aren't that very much</p>

								<p>motivated to actively participate in civic or social processes in communities they live in as they, understandably perhaps, don't see a reason to participate in these processes gathering other young people when this involvement usually doesn't generate any income for them. However, without some level of activeness in their lives, chances that they will improve their financial standing are not so good like they would be if they were more active in civic or social processes in their communities, as this tends to open a range of opportunities for a young person. Unfortunately, this philosophy of activeness often tends to be in confrontation with their potentially passive state of mind and this is something that we, as people working with young people for 11 years, see on a day-to-day basis. Unemployed young people facing economic obstacles, and especially those from low-income backgrounds, don't apply for participation in events that usually gather a lot of their peers and thus they don't participate in these events. Reasons are many. Moreover, if these young people are not participating in any form of civic and social processes in their communities they are also likely passive in job seeking as well as in investment in their personal development, closely connected to one's employability.</p> <p>For these and several other reasons we want to use this project to positively influence these young people motivating them for active participation and making them realize potential benefits for overcoming of personal economic disabilities (among other things) through active participation in lives of their communities. By steering them towards active participation we are likely to help them become more employable as youth participation brings practical benefits to youngsters as it offers chances for personal development, new acquaintances and strengthening of ties with various actors in communities in which they live in.</p>
3	192899	3.1TN	RS	2010	12.414,00	CITIZEN'S ASSOCIATION GENERATOR VRANJE	Free media and struggle against organized crime	<p>The project called "Free media and struggle against Organized crime" will be realized in Vranje in Southern Serbia in order to contribute to strengthen the impact of civil society in the struggle against organized crime in Europe as well as to promote the concept of legality and free media.</p> <p>The project will organize a six-day Training Course (TC) for trainers in Youth work about the struggle against organized crime. The TC will include participants from SEE and EU to work on media and campaigning as a tool for combating organized crime and promoting legality. They will have the opportunity to work together and gain new skills through open discussions, theoretical inputs, group work, practical exercises and actions. Through their experience in their own country, Youth will share information and new ideas on how to struggle efficiently against organized crime and raise people's awareness on this topic. Youth will work on three main topics: LEGALITY, human rights and justice; TRANSNATIONAL ORGANIZED CRIME (from corruption to human trafficking) and the means to struggle against it; FREE MEDIA and methods of campaigning and advocacy. The training course will include: training, human rights monitoring, lectures done by experts (such as journalists, magistrates, lawyers), and trial simulations. The TC will end by small actions based on media and means of information.</p>

But unfortunately there is in most communities a lack of knowledge using the potentials and resources offered through the cooperation between youth NGOs and public institutions as municipality institutions and to influence political decision making e.g. in the field of youth sustainably. To support the creation of needed synergy effects, the development of stable cooperation and the sustainable use of resources the planned Training Course in Kikinda, 05-11.06.2011 will communicate the knowledge and skills how to influence political decision making through future advocacy actions for the improvement of cooperation between Youth NGOs and public institutions on local level.</p>

5	192032	3.1YE	RS	2010	12.568,00	RESOURCE CENTRE LESKOVAC	"Let's Work Together"	<p>Resource Centre Leskovac from Serbia will, together with partners, organize a 6 day (excluding travel days) youth exchange under the project name LET'S WORK TOGETHER for 30 young people from Slovenia, Poland, Lithuania, Bosnia and Herzegovina, FYROM and Serbia aged 18-25 in order to discuss about environmental problems and importance of recycling in everyday life. The group will also raise awareness and learn the ways to ensure active participation of young people related to personal and everyday contribution to sustainable development and environmental protection. This youth exchange will be held in May during 6 working days, excluding travelling, in Southern Serbia region on the Vlasina lake. These surroundings are famous of healthy nature and countless flora and fauna and good preservation and protection of nature. Using different working methods (discussions in small mixed groups and plenary, group work, workshops, individual work, presentations, outdoor activities, etc) participants will experience process of principles such as dialogue, mutual understanding, giving constructive feedback, decision making, self-exploration, attitude of analytical approach.</p> <p>Participants will research situation related to given issues in their countries, present it to others and, together, develop a list of recommendation for taking personal responsibility for sustainable development. Recommendations, as well as conclusions and impressions of participants will be published in "Recommendations on sustainable development" in 7 languages (Serbian, Bosnian, Macedonian, Lithuanian, Polish, Italian and English. It will be distributed to young people in countries involved in the project.</p>

This 6 days training course will give the participants the possibility to improve their understanding and knowledge and will give them concrete skills on how to empower different minorities in their local communities, how to encourage minorities to actively participate in public life, raise and debate on specific questions relevant to minorities and young people with fewer opportunities on the basis of non formal education.</p> <p>The diversity of the partners and countries involved in this project only assists the learning outcomes to be bigger and more diverse.</p>

As a youth worker you encounter conflict in your everyday work. The training "Non violence communication and Conflict resolution - piece of cake" train youth workers what conflict is how to deal with it through non-violent conflict resolution.</p> <p>This intense training will train 24 youth workers using non-formal methods. The training takes place in Serbia. Participants will share experiences and explore personal, cultural and political similarities and differences to learn about different approaches conflict. Methods involved in the training are simulations, role playing and forum theatre. We will use combination of experiential learning and small theoretical inputs from the trainers' team, as well as plenary discussions and work in small groups. The course is based on learning by experience, learning by doing and learning through interaction. By applying these methods we aim a chance for participants to get personally acquainted with them (experimental level) and to offer tools and methods to transform conflict and non-violent conflict resolution.</p> <p>These tools and methods will be used by the participating youth workers to develop an experiential follow-up workshop. The follow-up workshop will be aimed at youth from minority and other marginalized groups (with disability, from rural regions etc.). Since these groups are a vulnerable part of society, the workshop should offer them the opportunity to participate in society and the skill how to deal with confrontations and conflict in nonviolent way.</p> <p>The training is organised by 6 non-governmental (youth) organisations from European Union and the Western Balkans: Ireland, Italy, Bosnia and Herzegovina, Former Yugoslav Republic</p>

								of Macedonia, Slovenia and Serbia. These regions experience(d) different levels and types of conflict and deal with conflict in different ways, this will be used in the training to explore cultural diversity and its relation to conflict.
8	192831	3.1TN	RS	2010	19.669,00	BALKAN INITIATIVE FOR TOLERANCE	Art of commYOUication	<p>In a today's life, with limited time and limited resources art of presenting the idea became the crucial skill to help us get the attention for certain issues we want to raise.</p> <p>Training course 3.1 Art of commYOUication will bring together 10 countries - Serbia, Bosnia and Herzegovina, Albania, Montenegro, Ukraina, Estonia, Italy, Romania, Slovenia and Poland to work on art of communication as a tool for better promotion of youth work and support of youth needs. TC will be organized in Serbia, it will include 8 working days and it will gather 30 participants active in youth work. Working methodology is non formal learning, through workshops and practice - learning by doing. All workshops will be dealing with different tool for strategic communication and will use YiA annual priorities themes as a case study.</p> <p>Main topics that will be discussed through workshops and lectures are:</p> <ul style="list-style-type: none"> <li>- Building communication strategy -"designing and developing tools;</li> <li>- Tools for media communication; case study - poverty and social exclusion;</li> <li>- Tools for successful communication with political decision makers; case study – youth Unemployment;</li> <li>- Tools for communication with community, stakeholders and funding agencies; case study - global challenges</li> <li>- Tools for communication with target audience (youth); examples from Serbia</li> <li>- Grassroots Mobilization tools; recruiting and retaining volunteers, examples from the Serbian movements in the nineties</li> </ul> <p>Objective of this project is to develop communication strategies in youth work that will lead towards main aim: greater impact of youth work in our communities and greater understanding of youth problems by wider public.</p>
9	192035	3.1YE	RS	2010	12.568,00	RESOURCE CENTRE LESKOVAC	Serbia "Youth for Youth"	<p>Millions of people from all the Europe and world are living in countries as a group of people which differ from larger group in matter of race, religion, political, etc. having full rights, but sometimes not. Freedom of declaring yourself as a member of some minority group in country of residence, sometimes is dragging obscure generalisation and opinions from 'majority' groups that are without any arguments, especially in the Balkan region. Serbia is Balkan country and for many years even decades, is trying to solve this problem. Serbia has sixteen different national councils of minorities existing today, with elected representatives to Ministry of human and minority rights, but even with this national bodies, minorities and their position quite often are not taken in consideration. The International Youth Exchange, which we will organize from the 20th May of 2011 to the 25th of May of 2011 (excluding travel days) in Serbia aims to speak about involvement of youth from minority group and their integration. It will involve 36 youngsters from different economical, social, cultural and religious backgrounds from 6 countries (3 Programme Countries + 3 from South East Europe Countries). This youth exchange will be based on non-formal education methodology; it will be lead by an experienced international core team, creating a space for the participants for raising their awareness about the situation of youth from minority groups in Europe, making them reflect about their role as youth workers, by promoting concrete strategies for the inclusion and integration of youth in societies. We also aim to identify differences and commonalities by sharing their personal experiences, discussing about the roots and ways of overcoming immigrants discrimination, developing inter-cultural communication skills and motivating the participants to multiply the acquired knowledge in various follow-up events in local and international level.</p>
